- This offer is valid for the installation of a NEW furnace with an electronically commutated motor (ECM). Installation of a replacement ECM in an existing furnace does not qualify for this Contractor Reward. Equipment must be purchased and installed between January 1, 2018 and December 31, 2018.
- Approval of this application is subject to approval of the customer's/member's Residential HVAC Incentive Application. Contractor agrees to the Terms and Conditions of that application. See michigan-energy.org for the appropriate Residential HVAC Incentive Application.
- The 2018 Energy Optimization program is available for electric utility customers/members in the following electric service territories: Alger Delta Electric, Great Lakes Energy Cooperative, Midwest Energy & Communications, City of Escanaba Electric, Homeworks Tri-County Electric Coop, Presque Isle Electric & Gas Coop, Cloverland Electric Cooperative, Ontonagon REA, City of Stephenson, and Newberry Water & Light Board.
- Funds for rewards are limited and available on a first-come, first-served basis. Total annual Contractor Reward amount is limited to \$2,500 maximum per Trade Ally.
- This application must be submitted within 60 days of the most recent installation listed above.
- MECA Energy Optimization program or any participating utility will not be responsible for any taxes that may be imposed on your business as a result of the payment of rewards. Rewards when aggregate totals \$600 or more in a calendar year will be reported to the IRS unless you are exempt. You are urged to consult your tax advisor concerning your tax liability.
